Consequent upon the introduction of revised pay structure under the Gujarat Civil Services (Revision of Pay) Rules, 2009 with effect from 1-1-2006, Government is pleased to decide that in modification of Government Resolution No. PGR/1098/10/M, dated 20<sup>th</sup> January, 1998 as amended from time to time, Compensatory Local Allowance and House Rent Allowance to State Government employees shall be admissible at the following rates:-

### (1) Compensatory Local Allowance

- The list of classification of cities/towns has been revised viz., A-1 to "X", A, B-1 & B-2 to "Y" for the purpose of Compensatory Local Allowance is enclosed at 1. Annexure-I.
- The list of classification of cities/towns has been revised viz., A-1 to "X", A, B-1 & B-2 to "Y", C and unclassified to "Z" for the purpose of House Rent Allowance is 2. enclosed at Annexure-II.
- The employees stationed at Gandhinagar will continue to draw HRA/CLA at the above revised rates applicable to "Y" Class city as per the provision of Gujarat Civil Services 3. (Additions to Pay) Rules, 2002.
- Pay for the purpose of these orders, will be pay drawn in the prescribed pay band plus the applicable grade pay; including stagnation increment(s) and non-practicing allowance, 4. but shall not include any other type(s) of pay like special pay or personal pay etc.
- In respect of those employees who opt to retain their pre-revised scales of pay, the pay for the purpose of these orders shall also include, in addition to the basic pay in the 5. applicable pre-revised scales, stagnation increment(s), Dearness Pay and Non-Practicing Allowance as per the order, dtd. 1-1-2006.
- The other conditions at present applicable for grant of HRA in case of sharing of 6. accommodation and other categories shall continue to be applicable.
- These orders shall be effective from 1-4-2009. For the period from 1-1-2006 to 31-3-2009, the above allowances will be drawn at the existing rates on the notional pay in 7. the pre-revised scale.
- These orders shall apply mutatis-mutandis to the Panchayat employees. 8.
- These orders shall apply mutatis/mutandis to the State Grant-in-aid Institutions, to whom 9. Finance Department has sanctioned the benefit of Fifth Pay Commission.
