
The State Government has issued the instructions regarding Fixation of Pay and Payment of arrears on account of revision of Pay and allowances vide Government Resolution dated 20<sup>th</sup> March, 2009 and arrears relating to increase in pay and increases granted in the rates of allowances are required to be credited to the General Provident Fund account of the employees concerned in the five equal yearly installments with five years 'Lock in period' on each installment after verification of the pay fixation cases as provided in the orders, referred to above at no.(1) & (3).

It was expected that the work relating to payment of first installment of arrears will be completed during Financial Year 2009-10 i.e. on or before 31<sup>st</sup> March and full provision was, therefore, made in the Budget for the year 2009-10. Necessary instructions to credit the first installment of arrears to the G.P.F account of the employees subject to verification and with the condition that if the credited amount found to be in excess after verification it shall be adjusted in second installment to be credited in employees G.P.F. account, were issued by the Government vide Finance Department circular dated 18<sup>th</sup> January, 2010.

It has come to the notice of the Government that some offices of the State Government and Panchyats have still not credited the first installment of arrears payable to the employees, to G.P.F account due to

unavailability of sufficient/adequate grant for the year 2009-10. In the matter it is decided to relax the provision made under Rule 84.(1)(ix) of The Gujarat Treasury Rules, 2000, Para. 100 of Gujarat Budget Manual and Para 2.1 of Schedule-I of Finance Department Resolution No. TZR-102000-365-Z dated 30-9-2000 and allow to submit the bills of first installment of arrears without Fund Availability Certificate to PAOs/Treasuries. All the Government Departments/ Heads of the Departments/Heads of Offices are hereby instructed to take immediate action and the first installment of arrears payable to employees in year 2009-10 shall have to be credited to the G.P.F A/c of the employee concern on or before 31<sup>st</sup> March, 2010. It will be the personal responsibility of the Drawing and Disbursing Officer of the offices concern.
