RESOLUTION :

Under the Government Resolution dtd. 7-1-1998, mentioned in the preamble, the State Government has decided to grant the benefits of its revised pay-scale and other allowances to the employees of State Government on the line of Central Government.

2. Consequent to this decision, Government is pleased to enhance the existing medical allowance of Rs. 75 to Rs. 100 per month.
3. This order shall be applicable to the employees and pensioners of State Government, employees and pensioners of Parastatal and Primary and Secondary School teachers as well as work-charged employees (who have completed the service of one full year without any break).
4. This order shall be implemented with effect from 1-6-1997.
5. The above mentioned medical allowance is subject to the Government Resolution, Health and Family Welfare Department, dated 31st March, 1982 and also subject to the conditions under amendments made therein from time to time.
6. Other conditions pertaining to the accounting systems as well as offering option shall be as it is.
