**RESOLUTION:**

Consequent upon the introduction of revised pay structure under the Gujarat Civil Services (Revision of Pay) Rules, 2009 with effect from 1-1-2006, Government is pleased to decide that the Dearness Allowance admissible to all State Government employees shall be admissible from the date mentioned below at the following rates :-

<b>Date from which payable</b>	<b>Rate of Dearness Allowance per mensem</b>
From 1-1-2006	No Dearness Allowance.
From 1-7-2006	2% of basic pay + NPA, where applicable.
From 1-1-2007	6% of basic pay + NPA, where applicable.
From 1-7-2007	9% of basic pay + NPA, where applicable.
From 1-1-2008	12% of basic pay + NPA, where applicable.
From 1-7-2008	16% of basic pay + NPA, where applicable.

2. The payment of Dearness Allowance under these orders from the dates indicated above shall be made after adjusting the installments of Dearness Allowance already sanctioned and paid to State Government employees w. e. f. 1-1-2006 vide F. D. G. R. No. VLB-102005-GOI-12-CH, dated 12-05-2006 and 5-10-2006, G.R. No.VLB-102007-GOI-06-CH, dt.16-04-2007, G.R. No.VLB-102007-GOI-12-CH, dated 1-10-2007, G.R. No. VLB-102008-GOI-1-CH, dated 10-4-2008.

3. The term 'basic pay' in the revised pay structure means the pay drawn in the prescribed pay band plus the applicable grade pay but does not include any

other type of pay like special pay etc. For the purpose of calculation of dearness allowance, non-practicing allowance, where applicable, shall be taken into account as at present.


4. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of the Gujarat Civil Service (Pay) Rules, 2002 Rule - 9 (53) .

5. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.

6. The benefit of these orders shall apply to the Primary Teachers and the employees who are on deputation or transferred to Panchayats and the work-charged employees with certain modification. On the same line the expenditure incurred due to sanctioning of Dearness Allowance because of these orders by Panchayats, Local Bodies and Municipalities, to its employees, and Non-Government Secondary Schools to their teachers and grant-in-aid institutions to their employees will be regularized as per the conditions laid down in these orders. The expenditure that will be incurred due to these orders will be liable for grant on the condition that the portion of the difference of Dearness Allowance should not be more than that of the portion of difference of Dearness Allowance to be paid to the employees at par with State Government employees.

The provisions of these orders shall also apply to All India Services Officers.
